

# How to apply for your Director Identification Number (DIN)

There are 3 ways to apply for your DIN...

## 1. Online via your myGovID

### 1. Set up a myGovID account

For instructions on how to create an account, please follow the steps here:

### 2. Prepare your documents

You will need the following pieces of supporting documentation to verify your information with the ATO:

- o Your tax file number (TFN);
- o Your residential address (as held by the ATO);
- o Information from two of the following documents:
  - Bank account details;
  - An ATO notice of assessment;
  - Super account details;
  - A dividend statement;
  - A Centrelink payment summary or;
  - A PAYG payment summary.

### 3. Complete your application

Once you have created your myGovID and have your necessary information, apply for your DIN via the following link: <https://mygovid.gov.au/AuthSpa.UI/index.html#login>

The application should take no more than 5 minutes.

## 2. Apply by Phone

### 1. Prepare your documents

You need the following supporting documentation to verify your information with the ATO:

- o Your tax file number (TFN);
- o Your residential address as held by the Australian Taxation Office (ATO) and;
- o Two Australian identity documents - refer to this link for details:

In addition to the above information, you will need to answer two questions based on details the ATO knows about you.

### 2. Contact the ABRS on 13 62 50

Once you have collected all the listed information, phone the ABRS on **13 62 50** between 8:00am - 6:00pm (AEST), Monday to Friday.

## 3. Apply with a Paper Form

### 1. Download and fill out an application form

### 2. Gather copies of certified identity documents

In addition to the application form, you will need to provide one certified primary document and two certified secondary documents. ### 3. Send completed application form and certified proof of identity documents to the following address:

## Who can certify your documents?

The following individuals can certify copies of your original identity documents as true and correct:

- Barrister
- Solicitor
- Judge
- Justice of the Peace (JP)
- Minister of religion (who is authorised to celebrate marriage)
- Police officer
- Medical practitioner
- Bank, building society or credit union officer with at least five years of service
- Sheriff's officer
- Commissioner of Declarations (in Queensland only).
